### CAMERON UNIVERSITY ANNOUNCES MBA ADMISSION CHANGES

Announcing changes to the Master of Business Administration (MBA) admission requirements beginning Spring 2014.

Students must meet one of the following criteria:

- 1) have a minimum undergraduate Grade Point Average (GPA) of 3.5
- 2) have a minimum score on the Graduate Management Admission Test (GMAT) of 500 or a comparable converted score on the Graduate Record Examination (GRE) utilizing the GRE Comparison Tool for Business
- 3) have a minimum composite score of 1000 using the formula:  $\text{Score} = \text{GMAT} + (200 * \text{undergraduate GPA})$ .

The College of Law will offer a Master of Laws degree, a one-year program for attorneys holding law degrees from outside the United States.

The first class of students will enroll in the fall semester of 2014. After completing the LL.M., and depending on the courses selected by the student, graduates may sit for the New York Bar.
